### **Responsibilities:**

- Advise on industry best practices and provide professional mine health, safety, and security functional support for employees, supervisors, and management at i-80 mine, project, and exploration sites with goals to both eliminate and reduce the risk of injuries and incidents.
- Establish health and safety and security management systems for the company.
- Systems and support services developed will include training in hazard identification and correction, field level and form risk assessments and tools, planned inspections, communications with regulators, incident investigations, team-based development of policies and work procedures, visitor and site-specific training programs, attend and/or assist with audits and State and MSHA inspections, compliance, record-keeping and reporting, and emergency response.
- Assist management with administration of the Worker's Compensation program, including interaction with compensation insurers, monitoring of claims, and reporting and development of loss prevention and rehabilitation programs.
- Liaise with local response agencies, communities, regulators, and technical experts to continuously improve management systems and training.
- Assist management with the implementation and administration of policies and procedures to maintain a secure work environment and prevent any loss of property or product from company sites.
