Responsibilities

- Manage the air, land, and water quality and quantity monitoring programs including large complex data sets in database software
- Ensure quality assurance and quality control of data is acceptable for reporting and engineering decision making
- Document relevant field observations/notes and maintain monitoring equipment, reagents, and laboratory space
- Oversee maintenance of existing compliance monitoring network and the development of modifications
- Ensure all legal, compliance/permitting obligations and special projects associated with water management are achieved
