Position: **Drill Services Supervisor**

The Drill Services Supervisor will report to the Senior Geologist and is responsible for monitoring, evaluating, and enforcing safe practices related to drilling. This role acts as a liaison between geology, operations, environmental, contractors, and the Health & Safety department to ensure all work is carried out in compliance with i-80 Gold Corp's HSE standards, MSHA regulations, applicable state and federal requirements, and industry best practices.

The role includes, but is not limited to, conducting field inspections, coaching contractors and drilling crews, supporting investigations, drill pad design, inventory, and ensuring safe rig setup and operation. During non-active drilling periods, this position transitions to broader safety inspections and hazard identification duties.

Location: Ruby Hill Mine – Eureka, NV for 2026, expanding to include the Granite Creek Mine in 2027 onward.

Key responsibilities

- Champion safe work practices at all drill sites and ensures compliance with i-80 Gold HSE standards, MSHA regulations, and applicable state and federal requirements.
- Ability to recognize and stop any exploration activity deemed to be unsafe or likely to have an environmental impact due to inadequate management.
- Ensure safety and environmental requirements are imbedded in drilling programs.
- Plan, schedule, and supervise diamond and RC drilling programs from mobilization to demobilization.
- Optimize drill performance (ft/day, cost/ft, core recovery, downtime, mud use).
- Manage multiple drill rigs and crews across concurrent projects including surface transport, fuel supply, waste, and communications.
- Conduct regular safety and operational inspections at laydown yards and active drill sites (surface and underground), verifying proper rig setup, equipment condition, maintenance schedules, consumables, and safe work practices.
- Identify hazards and perform field-level risk assessments, particularly during rig mobilization, drill pad construction, sump development, and active drilling operations.
- Oversee drill pad design, sump construction, and ongoing maintenance to ensure sites are prepared for safe, efficient, and environmentally compliant drilling operations.
- Act as the primary on-site liaison between drilling contractors, the Geology/Exploration team, Operations, and the Safety Department to support safe and effective execution of drill programs.
- Lead or support incident investigations involving drilling crews, applying root cause analysis and ensuring timely completion and track of corrective actions.
- Ensure operators and contractors have the appropriate tools, equipment, and training necessary to perform work safely and effectively.
- Perform other duties as assigned in support of drilling and exploration activities.

Requirements/Qualifications

- High school diploma or GED
- 5+ years of experience in exploration or production drilling, preferably in underground environments with both core and RC.

- Strong knowledge of drilling safety standards, MSHA regulations, and field hazard recognition.
- Excellent verbal and written communication skills; able to lead safety discussions and document findings.
- Experience with contractor oversight, incident reporting, and compliance auditing.
- Provide professionalism and integrity in all interactions, with a commitment to upholding company values
- Ability to thrive in a fast-paced and dynamic work environment.
- Must be able to manage and prioritize multiple projects/tasks.
- MSHA blue card (surface & underground) preferred.
- Valid driver's license.

Physical Requirements

This position requires regular work in underground and surface mining environments. Must be comfortable working in confined spaces, around drilling equipment, and in variable weather or environmental conditions. Regular lifting (up to 50 lbs), walking/hiking on uneven ground, and use of PPE are required.
